# Facing Life's Struggles with a Smile

It was a struggle to grow up in an abusive environment in East Palo Alto, but today Wendy, a Self Sufficiency Program graduate, smiles brightly and teaches her four children to always face life's struggles with the same smile.

At the age of 15, Wendy found herself homeless and later became a single mother of three girls. Even so, she was able to complete her GED and some coursework towards her dream of becoming a Probation Officer. "I strongly believe that everyone deserves a second chance in life. I want to be able to help individuals re-integrate into society by assisting them with transition and providing them the tools to be productive citizens," says Wendy.

In the six years that Wendy was in the Self Sufficiency Program, she earned a Bachelors Degree in Criminal Justice from San Francisco State University and secured a job with the County of San Mateo Probation Department, as an Office Specialist. Through HIP Housing, Wendy was also connected to an internship with the U.S. Pretrial Services.

As a result of these experiences Wendy was invited to take the Probation Officer test and is awaiting results. Her new goals are to get a Masters in Public Administration and open a non profit that will assist juveniles and adults.

Wendy and her partner expanded their family and have a two year old son. Together with Wendy's three teenage daughters, they have created a loving, safe and stable home.

Wendy has worked tirelessly to accomplish her dreams. She does it all for her children. Her advice to them is "don't give up,...Dream big, you are worth it!"

Aron Hoffman -- Former Board Member, Donor and HIP Housing Champion

On March 30, 2018 the community lost one of its beloved leaders, Aron Hoffman. former San Mateo Mayor and former HIP Housing Board Member, Aron's commitment to his community was a constant hallmark throughout his life. He sat on the board of numerous local organizations, was a committed Rotarian, was elected to San Mateo City Council and was the Mayor in 1984 and 1985. His long-standing work with the J.H. Robbins Foundation, helped better our community by supporting numerous non profits. It was Aron's leadership and passion to help families in need that secured a \$100,000 grant from the J.H. Robbins Foundation to build HIP Housing's shared house in San Carlos in 1995, named Robbins Nest. Since then, dozens of low-income families with young children have called it home while they completed their educational goals. Aron's legacy lives on through the success of these families.




